CHANGES TO THE NHS LOW INCOME SCHEME (LIS)

SUMMARY

1. From 1 April 1996 new leaflets, posters and other material about NHS charges, help with optical costs and hospital travel costs will be introduced. A full list of the new material with code numbers is given at Annex 1.

From 19 March 1996 certain people in Scotland will be entitled to LIS charges certificates for periods longer than 6 months, and a number of technical changes will be made. The changes to the LIS are included in the NHS (Travelling Expenses and Remission of Charges) (Scotland) Amendment Regulations 1996. A small supply of this Regulation will be sent to Health Boards in due course.

Later this year, LIS "AG" forms will be re-numbered and "HC" new versions will be introduced.

General Medical Practitioners are asked to bring to the attention of midwives and health visitors the introduction of a revised version of form FW8 (application for exemption certificate during pregnancy or following birth of a baby).

NEW FORMS, POSTERS, LEAFLETS AND DISPENSER

- 3. These have been produced for use from 1 April 1996 and replace the material listed in paragraph 6.
 - 3.1 Leaflets

HC11 Are You Entitled to Help with Health Costs?: to be available from main Post Offices, Social Security offices, hospitals, NHS contractors and Health Boards. This is primarily for use by the public and explains entitlement to help with costs by user group, for example, people aged 60 or over, people receiving DSS benefits.

- 5.1 Leaflet HC13 will be distributed in May. Further supplies can thereafter be obtained from your Health Board or HMSO.
- 5.2 An initial supply of forms EC92A and FW8 (revised) will be sent to Genearl Medical Practitioners, thereafter copies should be ordered from your Health Board.

- 7. For information: there are some changes to the Low Income Scheme arrangements. The main one is that people in Scotland in the following groups who make a LIS claim on or after 19 March 1996 will generally be sent charges certificates (AG2/AG3) for periods longer than 6 months:-
 - 7.1 people who are disabled or who are aged 60 or more will be sent a certificate for 12 months;
 - 7.2 students in their final year will be sent a certificate to the end of the course;
 - 7.3 other students will be sent a certificate to the start of the next academic year;
 - 7.4 self-employed people who provide appropriate accounts will be sent a certificate for 13 months.

You do not need to take any action.
