# Remuneration Increase 2016-17: Chairs And Non-Executive Members

1. I am writing to advise you of the revised annual rates of remuneration payable to Chairs and other Non-Executive members of Health Boards, Special Health Boards and Healthcare Improvement Scotland. Other Health Bodies will be advised separately by their Scottish Government Sponsor Teams.

# Background

2. The revised rates reflect a 1% increase, in accordance with the Public Sector Pay Policy for 2016-17 and are set out in the table overleaf.

3. Please note that this replaces the information contained in CEL 18 (2014).

## Action

4. The revised rates are payable from 1 April 2016.

## **Travel & Subsistence**

5. It has been brought to our attention that NHS Boards are handling travel and subsistence claims for non-executive members differently.

6. It appears that some NHS Boards have confirmed that expenses (travel from home to work/meetings) for Non-Executive Directors (NXDs) are paid gross and that there is a PAYE Settlement Agreement (PSA) in place.
