



## TEMPORARY INCREASE TO NHS SCOTLAND MILEAGE RATES - EXTENSION

1. [DL\(2022\)11](#) announced a temporary increase to NHS Scotland mileage rates for the first 4 months of the 2022-23 financial year (1 April to 31 July 2022). The letter indicated that the Secretariat of the Scottish Terms and Conditions Committee (STAC) would monitor the position and confirm to the service any agreed changes.
2. Having discussed the matter, STAC Secretariat have approved a 4 month extension to the current arrangement, from 1 August to 30 November 2022. As indicated previously, a minimum of 2 months' notice will be provided of reverting to the previous position.
3. For ease of reference, the enhanced rates which are applicable are attached at Annex A. These have now been supplemented with enhanced rates for the full range of approaches available within Medical and Dental terms and conditions. Payroll departments will automatically calculate any adjustments which need to be made in this regard so staff should avoid making duplicate applications for any miles already covered in 2022-23.
4. STAC will continue to consider relevant aspects of remuneration for business travel including rates for lease cars in the interim and inform the service of any agreed positions, as appropriate.

### Action

5. NHS Boards and Special Health Boards should take note of the provisions set out in the letter and ensure that these are applied, as indicated.
