Remuneration Increase 2025-26, 2026-27 and 2027-28: Chairs and Non-Executive Members

1. Following the Scottish Budget announcement in December 2024, I am writing to advise you of the revised annual rates of remuneration payable to Chairs and Non-Executive members of Health Boards, Special Health Boards, NHS National Services Scotland and Healthcare Improvement Scotland. Other NHS Bodies will be advised separately by their Scottish Government Sponsor Teams

Background

- 2. Remuneration rates for Public Bodies are governed under the Public Sector Pay Policy. DL (20024)30 explained that Health Boards, Special Health Boards (including NHS National Services Scotland) and Healthcare Improvement Scotland have been reclassified as Tier 1 Public Bodies and that the transition would be phased over 4 years.
- 4. This DL sets out the remuneration uplifts of the daily fee rates for the next 3 years (2025-26, 2026-27 and 2027-08). Details provided at Annex A.
- 6. Please note that this DL replaces the information contained in DL(2024)30.
