Medicine Supply Alert Notice

Clomethiazole 192mg capsules

Priority: Level 2*

Valid until: mid-July 2024

Issue

- 1. Clomethiazole 192mg capsules are out of stock until mid-June 2024.
- 2. Clomethiazole 31.5mg/ml oral solution sugar free is currently out of stock until mid-July 2024.
- 3. Alternative hypnotics/anxiolytics remain available.
- 4. Unlicensed supplies of clomethiazole 192mg capsules can be sourced, lead times vary.

Advice and Actions

- 5. Prescribers should not initiate new patients on clomethiazole 192mg capsules until the shortage has resolved.
- 6. Where people have insufficient supplies to last until the re-supply date, prescribers should:
 - review individuals to determine reason for being on this treatment;
 - if treatment is no longer considered necessary, **abrupt withdrawal must be avoided**, and people should be withdrawn by slow dose reduction or switching to an approximately equivalent dose of diazepam, which is then tapered down:
 - local protocols for benzodiazepine withdrawal, where available, should be referred to and advice sought from mental health teams for a suitable withdrawal regimen tailored to a person's needs.
 - for people unwilling/unable to stop treatment:
 - o if receiving as an anxiolytic, consider appropriateness of switching to other short acting agents such as oxazepam and lorazepam, or
 - if receiving for insomnia, consider appropriateness of switching to a Z drug (zopiclone, zolpidem) or a sedating antihistamine (promethazine), in preference to a benzodiazepine.
 - note dose conversions of clomethiazole to benzodiazepines should be approached with caution as there are limited data;
 - consider whether high dose switches to alternative medicines or switches in people with renal impairment can be safely done in primary care or if specialist advice should be sought from mental health teams or alcohol/drug dependency services;
 - consider prescribing unlicensed clomethiazole capsules only where switching to a licensed alternative is not appropriate;

- if the above options are not considered appropriate, advice should be sought from specialists on alternative management options.
- 7. GPs and other prescribers working in the community should refer to local protocols for information on drug regimens for medically assisted withdrawal from alcohol.

Additional Information

Clinical Information

- 8. Clomethiazole is a short acting sedative and muscle relaxant with anticonvulsant effect, which is pharmacologically distinct from both benzodiazepines and barbiturates. It is licensed for the management of restlessness and agitation in the elderly, short term treatment of severe insomnia in the elderly and treatment of alcohol withdrawal symptoms where close hospital supervision is also provided.
- 9. Clomethiazole should not be used in community-based assisted withdrawal from alcohol because of the risk of overdose and misuse. Chlordiazepoxide or diazepam are the drugs of choice for alcohol detoxification.
- 10. Abrupt withdrawal of clomethiazole should be avoided as it could have serious consequences for some people.

- 13. Any decision to prescribe an unlicensed medicine must consider the relevant guidance and Health Board or local governance procedures. Unlicensed imports do not undergo any central quality assessment or suitability evaluation. Therefore, any import must be locally assessed in line with local unlicensed medicines processes.
