Medicine Supply Alert Notice

Diltiazem (Angitil[®] SR) 90 mg modified-release capsules

Priority: Level 2^{*} Valid until: w/c 28 April 2025

Issue

- 1. Diltiazem (Angitil[®] SR) 90 mg modified-release capsules are out of stock until w/c 28 April 2025.
- 2. Diltiazem (Tildiem Retard[®]) 90 mg prolonged-release tablets remain available and can support increased demand.
- 3. Diltiazem (Adizem-SR[®]) 90 mg modified-release capsules remain available but cannot support an increased demand.

Advice and Actions

- 4. Where a person has insufficient supplies to last until the resupply date, prescribers should:
 - consider prescribing Tildiem Retard[®] 90 mg prolonged-release tablets, ensuring no intolerance to excipients, and the person is counselled on the appropriate dose (see additional information section below); and
 - for people prescribed diltiazem for angina, advise them to report worsening of symptoms including increased need for glyceryl trinitrate (GTN) and side effects; and
 - for people prescribed diltiazem for hypertension and where there are concerns about the stability of their blood pressure, re-check blood pressure within a month after changing brands.

Clinical Information

- 5. Tildiem Retard[®] 90 mg prolonged-release tablets are licensed for the management of angina pectoris and mild to moderate hypertension.
- <u>The BNF states that</u> 'different versions of modified-release preparations containing more than 60 mg diltiazem hydrochloride may not have the same clinical effect. To avoid confusion between these different formulations of diltiazem, prescribers should specify the brand to be dispensed'.
