## **Medicine Supply Alert Notice**

## Phenobarbital 15mg/5ml elixir

Priority: Level 2\*

Valid until: late June 2025

#### Issue

- 1. Phenobarbital 15mg/5ml elixir (500ml) is out of stock until late June 2025.
- 2. Specials of phenobarbital 15mg/5ml **oral solution** and phenobarbital 15mg/5ml **oral suspension** remain available (see Additional information section)

#### **Advice and Actions**

- Prescribers should not initiate patients on phenobarbital 15mg/5ml elixir until the supply issues have resolved.
- 4. Where patients have insufficient supplies to last until the re-supply date, clinicians should:
  - review patients and consider prescribing Specials of phenobarbital 15mg/5ml oral solution or oral suspension, checking the list of excipients and pharmaceutical differences to ensure suitability for patient (see Additional information section); and
  - advise patients that they are receiving the same drug therapy but from a different manufacturer to avoid a break in treatment, and to report signs indicating a potential loss of seizure control and/or new/worsening side effects.

#### Clinical Information

5. Phenobarbital 15mg/5ml elixir is licensed for the treatment of all forms of epilepsy except absence seizures. It is a category 1 antiepileptic drug where patients should be maintained on a specific product as clinically relevant differences between different manufacturers' products might occur, even when the pharmaceutical forms are the same and bioequivalence has been shown. However, in the event of a shortage, maintaining treatment with another manufacturer's product is necessary to avoid treatment interruption and potential loss of seizure control.

# Guidance on ordering and prescribing unlicensed medicines

6. The following Specials manufacturers have confirmed they can source unlicensed phenobarbital 15mg/5ml oral liquid, solution or suspension. Please note there may be other companies that can also source supplies. The full list of excipients should be requested from each supplier and reviewed for appropriateness as these can vary.

## Specialist Pharmacy Service (SPS) website

The tool is located under the Tools tab and then click on the Medicines Supply option.

We encourage prescribers, pharmacy professionals, and pharmacy procurement leads in Scotland to register with the SPS website and use its Medicine Supply Tool to stay up to date concerning medicines supply disruptions. Please be aware that while medicines supply issues will appear on the SPS website, some of the recommended actions may not always be appropriate / relevant within the Scottish context.
