# A SCOTTISH GOVERNMENT CONSULTATION EXERCISE ON THE FUTURE OF ORAL HEALTH

## Summary

1. This letter advises of Scotland's Oral Health Plan – A Scottish Government Consultation Exercise On the Future of Oral Health. The consultation was launched today, 15<sup>th</sup> September.

## **Background**

- 2. Since the publication of the last Dental Action Plan in 2005, the landscape in NHS dentistry has changed considerably, with significant improvements in oral health amongst children, better access for patients to a NHS dentistry, and a substantial increase in the numbers of dentists, and dental staff, routinely providing NHS dental care.
- 3. The purpose of this consultation exercise is to build on this success story. We face a complex set of challenges around oral health inequalities, an ageing population, and how we shift the emphasis from restorative dentistry to a more preventive-focused approach.

## Roadshow Events

5. Central to the consultation exercise is ensuring that dental professionals are informed about the drivers for change and the strategic priorities. Therefore, a series of roadshow events have been organised throughout Scotland. The dates, times and venues for the roadshow programme are included in the attached memorandum, along with the appropriate booking details. The roadshows are available to dentists, dental care professionals, health care professionals with an interest in dentistry, including health care managers. ## Patient Participation

These packs will be sent to NHS Boards stores for onward distribution to practices. Each pack will consist of a poster and 100 leaflets for each practice in their Board area. In addition to this, we will also be arranging a number of focus groups for patients which will be held around the country.
