ADDITIONAL PHARMACEUTICAL SERVICES GLUTEN FREE FOOD PRESCRIBABLE PRODUCT LIST

Summary

1. This Circular advises that the Gluten Free Food Prescribable Product List to be used in conjunction with the community pharmacy Gluten Free Food Service (GFFS) has been updated.

Background

2. Circular [PCA\(P\)\(2013\)29](#), published on 28 November 2013, announced the introduction of the new Gluten Free Food Service in community pharmacies on a trial basis. In September 2015, Circular [PCA\(P\)\(2015\)24](#) advised that following a review of the trial period, the service was to continue as an Additional Pharmaceutical Service.

3. Only products which are listed in the Gluten Free Food Prescribable Product List and on the formulary established by the NHS Board concerned may be provided under this service.

Detail

4. The Gluten Free Prescribable Product List has been updated with effect from 10 June 2016 to take account of new products and discontinued lines in the last 12 months. The list is consistent with the Advisory Committee on Borderline Substances (ACBS) advice. The updated list is attached as an Annex to this Circular.

5. Community Pharmacy Scotland has been consulted on the contents on this Circular.

Action

6. NHS Boards are to review their formularies for the GFFS and update them as necessary.
