Summary

1. This Circular informs NHS Boards and community pharmacy contractors of the intention to continue funding for Community Pharmacist Practitioner Champions in 2016-17.

Background

- Funding was provided to Boards in 2015-16 for Community Pharmacist Practitioner Champions. The existing arrangements are rolled forward from 1 April 2016.
- 3. The allocations to Boards for 2016-17 are based on NRAC share and are set out in the attached Annex.

- 4. The original role and remit of the Practitioner Champions was set out in NHS Circular <u>PCA (P)</u> (2005)20. During 2016-17 they are expected to target their support on the following areas:
 - the Chronic Medication Service (CMS) focusing on both the serial prescribing and dispensing and pharmaceutical care planning elements, including use of the intervention tools, and providing local advice on closer partnership working as described in Circular PCA(P)(2016)15; and

Supporting community pharmacists and their teams to develop and embed continuous improvement in community pharmacy as per Circular PCA(P)(2016)15, issued on 16th September 2016. The priority for this year will be to complete the Safety Climate Survey and all community pharmacy teams are expected to undertake, or make preparations to undertake, this activity by the 31st March 2017. It is anticipated that the Champions will support this both in terms of preparing and learning from the activity. The Scottish Patient Safety Programme (SPSP) will be supporting 'training the trainers' events for NHS Boards as part of preparing for a series of Quality Road-show Workshops. It is envisaged that Boards will include their pharmacy champions in these training events and encourage their attendance at the Road-show Workshops in order to ensure they have the necessary knowledge to support their community pharmacy teams.
