PHARMACEUTICAL SERVICES AMENDMENTS TO THE DRUG TARIFF PART 7 IN RESPECT OF REIMBURSEMENT ARRANGEMENTS FROM 1 JUNE 2017 AND DRUG TARIFF PART 7 AND PART 11 DISCOUNT CLAWBACK SCALE

Purpose

1. This circular advises community pharmacy contractors and NHS Boards on the amendments to the Drug Tariff Part 7 (generic drugs) along with changes to the Drug Tariff Part 7 and Part 11 clawback scales.

Background

2. Circular PCA (P)(2016) 7 and PCA (P)(2016) 11 advised of amendments to the Drug Tariff in respect of remuneration and reimbursement arrangements for 2016-17.

3. A settlement has now been reached with Community Pharmacy Scotland on a 1 year community pharmacy funding package to cover the financial year 2017-18.

4. Circular PCA (P)(2016) 17 advised that the Drug Tariff in respect of the Part 7 discount clawback rate from 1 April 2016 would be reset to 3% and the Drug Tariff in respect of Part 11 discount clawback would be reset to 7.69%.

5. The circular also advised that the clawback would rates would be reviewed in accordance with the protocol established as part of the community pharmacy funding arrangements.

Drug Tariff Part 7 (generic drugs) changes

6. This circular advises community pharmacy contractors of a list of Drug Tariff changes which take effect from 1^{st} June 2017 – see attached **Annex A**.

Drug Tariff Part 7 Discount Clawback

7. The target discount clawback in respect of Part 7 will roll forward at the current rate of 3% until 31 May 2017 after which the Part 7 discount clawback will be reset to **0%** effective 1 June 2017 to 31 March 2018.

Drug Tariff Part 11 Discount Clawback

8. The Part 11 discount clawback rate to the Drug Tariff shall be reset to **6.93%** effective 1 June 2017. As such the target clawback has been adjusted accordingly. See attached **Annex B** for further detail on the scale.

9. Further information on the detailed changes to the Drug Tariff in respect of remuneration and Margin Sharing Arrangements, when finalised with Community Pharmacy Scotland, will be circulated in due course.

10. Community Pharmacy Scotland has been consulted on the Drug Tariff amendments and the contents of this circular.
