Summary

**MEMORANDUM TO NHS:
PCA(O)2020(3)**

Summary

1. This Memorandum provides updated information on the provision of domiciliary eyecare services carried out under General Ophthalmic Services (GOS) arrangements in Scotland, during the delay phase of COVID-19. It also contains guidance to NHS Boards regarding practice inspections.

Cessation of Domiciliary Visits

2. Scotland is now in the **delay phase** of COVID-19. Steps must be taken to ensure those individuals who are in the high risk categories are, as far as is possible, protected from infection.
3. Providers of GOS in Scotland are therefore instructed to cease the provision of **routine** domiciliary eyecare services - to include patients in their own homes as well as those in day or residential centres - with immediate effect.
4. The Scottish Government is currently developing a process to ensure financial sustainability for those practices and domiciliary eyecare providers directly affected by COVID-19. A further communication on this will be issued very shortly.

Practice inspections

5. NHS Boards are advised that, until further notice, they should consider postponing all practice inspections.
