BREAK IN SERVICE UNDER AGENDA FOR CHANGE

Summary

- 1. The following agreement, which has effect from 1 October 2004, has been reached in partnership under the aegis of the Scottish Terms and Conditions Committee (STAC).
- 2. Where a member of staff resumes NHSScotland employment after a break in service, for the purposes of determining the appropriate pay point under the Agenda for Change terms and conditions handbook, that break will be disregarded where it has been for less than three calendar months.
- 3. Where a member of staff enters NHSScotland employment less than three calendar months after leaving previous NHS employment in England, Wales or Northern Ireland, that previous NHS employment will be taken into account when determining the appropriate pay point under the terms of the Agenda for Change terms and conditions handbook.

Cabinet Secretary approval

4. Employers should implement this agreement, which has been approved by the Cabinet Secretary for Health and Wellbeing under regulations 2 and 3 of the National Health Service (Remuneration and Conditions of Service) (Scotland) Regulations 1991 (S.I. 1991/537). A copy of the formal approval is attached.
